Regular Meeting
March 6, 2017

Francis Fruehan called the meeting to order at 7:00 pm and called for a salute to the Flag.

The minutes from the February meeting were read and approved on a motion made by Evan Everitt and seconded by Francis Fruehan, approved.

The Treasurer's Report was read, approved and held for audit on a motion made by Evan Everitt and seconded by Francis Fruehan, approved.

Public Comment: A resident asked if there had been a tax increase. Francis Fruehan explained there was no increase in millage but the Act 13 credit was reduced due to the decrease in Act 13 funds received.

All bids will be reviewed and awarded at the April meeting.

Evan Everitt gave the results from the 1979 Am General truck tractor that was put on Auctions International with a high bid of \$3,000. Evan said he is happy with the results and made a motion to accept the bid, Francis Fruehan seconded, approved.

Evan Everitt said he has one more truck he would like to put on Auctions International. This is a 1991-1993 Freightliner. Evan Everitt made a motion to advertise the truck on Auctions International, Francis Fruehan seconded, approved.

Evan Everitt said he would like to purchase a newer truck to make into a plow truck and has located a 2008 Freightliner truck from government surplus in North Carolina for \$8,400. Francis Fruehan made a motion to authorize Evan Everitt to move forward with purchasing the truck, Evan Everitt seconded, approved.

Francis Fruehan read the police report with 18 incidents for the month of February – including 10 traffic stops.

Evan Everitt gave the road report. John C McNamara Drive is in need of repaving from SR 167 to the Bottom of the hill behind the township building and the second section is from Kublos to SR 4002. He has talked to a representative from the state and was told each section would probably cost about \$100,000 per mile. The state would put the project out to bid and it would be prevailing wage.

Evan Everitt said that one the bridge/culvert on Pop's Hobby Lake Road is completed, the state would like to turn it back over to the township.

There is no new update regarding the pipe replacement at Wilson Swamp on SR 4002.
