Regular Meeting
March 2, 2020

Francis Fruehan called the meeting to order at 7:00 pm and called for a salute to the Flag.

Minutes from the February regular monthly meeting were read and approved on a motion made by Evan Everitt and seconded by Butch DeLousia, all approved.

The Treasurer report was read, approved and held for audit on a motion made by Evan Everitt and seconded by Butch DeLousia, all approved.

No public comment.

The bid package for the Silver Lake Township truck and equipment garage – Phase 1 Foundation and insulated metal building shell was advertised in the February 5 and February 12 editions of the Susquehanna County Independent. Bids were due by Monday, March 2, 7:00 pm for the bid opening. Two bids were received:

Hohn Construction with a bid of \$795,560.00. Package included the formal proposal, bidder affidavit page 8, certificate of insurance, bid bond, additional Addendum, schematics. Deduction Alternative #1 \$27,500 for eves omission; \$440/cubic yard for additional concrete.

D & M Construction Unlimited Inc. with a bid of \$679,900.00. Package included the formal proposal, bidder affidavit page 8, certificate of insurance, bid bond, additional addendum. Deduction Alternative #1 \$10,000; \$1.65/cubic yard for additional concrete.

Evan Everitt made a motion to advertise for flake calcium in 2,000 lb. super sacks, Butch DeLousia seconded, all approved.

Evan Everitt said there are additional items he would like to advertise on Auctions International – 2 Hopper Spreaders, old pickup truck box, rubber tire excavator and the Fire Company would like include a 1991 Ford ambulance in the posting as well – they will supply the necessary information for the posting. Evan Everitt made a motion to advertise on Auctions International, Butch DeLousia, seconded, all approved.

New Business: Francis Fruehan made a motion to reaffirm that the Road Master, Assistant Road Master and Supervisors are authorized to perform bid and construction administration for the township's buildings as part of their duties.

Evan Everitt gave the road report – the grant for the pipe replacement on Kelly Road has been approved. This project requires an engineer. Evan Everitt would like to hire Loren Salsman, PE with Carbon Engineering Inc. who has provided a cost of \$22,500 for the project. Choconut Township is doing a similar project with the same engineer. If Silver Lake and Choconut use the same engineer he would reduce his cost to \$20,000. Evan Everitt made a motion to appoint Loren Salsman, PE from Carbon Engineering Inc. for the project, Francis Fruehan seconded, all approved.

Francis Fruehan read the police report for the month of February with 3 incidents plus s traffic stops.

Evan Everitt made a motion to approve the bills for payment, Butch DeLousia seconded, all approved.

As no further business was presented, Francis Fruehan made a motion to adjourn, Butch DeLousia seconded, all approved.
