Regular Monthly Meeting
March 1, 2021

Francis Fruehan called the meeting to order at 7:00 pm and called for a salute to the Flag.

Minutes from the February meeting were read and approved on a motion made by Evan Everitt and seconded by Butch DeLousia, all approved.

The Treasurer report was read, approved and held for audit on a motion made by Evan Everitt and seconded by Butch DeLousia, all approved.

Public comment: None

The bid package for the Silver Lake Township Truck and Equipment Garage – Phase 2 – Slab Installation was advertised in the February 10 and February 17, 2021 edition of the Susquehanna County Independent. Bids were due at 7:00 pm on Monday, March 1 for the bid opening. Evan Everitt opened the bids received:

Insinger Excavating, LLC with a bid of \$126,937.00. Additional concrete if needed at \$150.00/cubic yard.

RHC Enterprises Inc. D/B/A Tri-State Builders with a bid of \$92,000.00. Additional concrete if needed at \$140.00/cubic yard.

Benedict Construction, Inc. with a bid of \$71,050.00. Additional concrete if needed at \$198.00/cubic yard

Evan Everitt verified each bid contained the bid bond, bidder affidavit and two pages of the Form of Bid Proposal.

Evan Everitt made a motion to accept the low bid from Benedict Construction of \$71,050.00, provided the documents in the bid package are verified to be complete, Francis Fruehan seconded, all approved.

Francis Fruehan read the instruction to Bidders and asked for a motion, that if the bid is complete, to authorize Francis Fruehan to notify the successful bidder with a Notice of Intent to Award the contract to the apparent successful bidder and it will be accompanied by the agreement with a copy of the bid submission. And within 15 days the successful bidder shall sign and deliver to the township the signed Agreement accompanied by the required insurance certificate and Bond and completed Form W-9. Evan Everitt made a motion, Butch DeLousia seconded, all approved.

Evan Everitt opened bids received for aggregate, hourly triaxle trucking, fuels and calcium chloride.

Evan Everitt made a motion to accept the Calcium Chloride bid from Schoenberg Salt, Butch DeLousia seconded, all approved.

Evan Everitt said he is looking to replace one of the International plow trucks. The truck he is looking at is through the Costars program – Western Star tandem axle two-wheel drive, Stainless box. Francis Fruehan made a motion to authorize Evan Everitt to purchase a new plow truck for an amount up to \$210,000, Butch DeLousia seconded, approved.

Francis Fruehan gave the police report – two incidents for the month of February.

Evan Everitt gave the road report – winter road maintenance. The tarp on the cinder building has ripped during one of the storms. It will need to be replaced or have pole building built on top of the existing concrete.
