

Silver Lake Township
Regular Monthly Meeting
October 3, 2022

Francis Fruehan called the regular monthly meeting to order at 7:00 pm and called for a salute to the flag.

Minutes from the September meeting were read and approved on a motion made by Evan Everitt and seconded by Butch DeLousia, all approved.

The Treasurer report was read, approved and held for audit on a motion made by Evan Everitt and seconded by Butch DeLousia, all approved.

Public Comment: None

A motion was made to put the 2007 International Plow Truck back out to bid on Auctions International. This is the same truck that had been advertised on Auctions International in the spring. Evan Everitt is hoping with winter approaching someone will be in need of a plow truck, and we will get a better price.

There is also a military surplus 10K generator that Evan Everitt would also like to advertise for bid on Auctions International.

Evan Everitt made a motion to advertise the 2007 International Plow Truck and the military surplus 10K generator on Auctions International, Francis Fruehan seconded, all approved.

Evan Everitt said he has contacted several dealerships for information on graders and said the prices are very high , in the \$340,000 range with a long wait for the equipment to come in. He said Forest Lake Township is in the process of purchasing a new grader and trading their existing grader in and is willing to sell the grader to Silver Lake Township for the same price they were offered for the trade in, \$220,000. The grader is a 2015 Cat 140M with a approximately 1,600 hours operating time. Evan Everitt made a motion to purchase Forest Lake Township's Cat 140M grader for \$220,000, Butch DeLousia seconded, all approved.

Francis Fruehan said budget work session will continue on Monday nights at 6:00 pm at the township building through the month of October. The proposed budget will be presented at the November meeting and adopted at the December meeting.

Francis Fruehan made a motion to again advertise the budget work sessions in the Susquehanna Independent as required, Evan Everitt seconded, approved.

Francis Fruehan gave the police report with 8 incidents for the month of September.

Evan Everitt gave the road report – getting road projects completed

Evan Everitt said he has a document from DEP that requires a signature to give DEP access to the quarry that is up behind the township building. There is already an existing easement. This just needs to be

updated. Francis Fruehan made a motion to authorize Evan Everitt to sign the document, Butch DeLousia seconded, all approved.

Evan Everitt made a motion to pay the bills as submitted, Butch DeLousia seconded, all approved.

As no further business was presented, Francis Fruehan made a motion to adjourn the meeting and Evan Everitt seconded, all approved.
